- 2. Shri Alok sharma, Returning Officer, resident of Flat No. 606, Torre Altus Tower, Omaxe Heights, Faridabad.
- 3. Shri Sanjay Kumar Gupta, Returning Officer, resident of Flat No. 704, Mantova Tower, Omaxe Heights, Faridabad.

General procedure for the election for the post of Tower Representatives of 61 electoral colleges as decided in the Executive Committee meeting will be as under:

- 1. Any OHRWA member from the respective college / colleges can cast the vote or contest the election for the position of Collegium Member (Tower Representative) provided that he/she has obtained the new membership of OHRWA on or before 13th Nov 2021 and In the case of membership already obtained on or before 31th Aug 2020, his/her membership is not suspended in the records of OHRWA as on 30th Jun 2021 due to non-renewal of membership OR is not suspended at any time due to any reason whatsoever as per OHRWA Byelaws.
- 2. The winning candidates will represent their respective College / Colleges in Collegium.
- 3. The Votes shall be polled only by the members of OHRWA of the respective college / colleges, according to the authentic list with Election Committee. Any objection, related to members list should brought to the notice of Election Committee latest by 17thNov 2021. Election Committee will resolve the matter latest by 20thNov 2021. The decision of Election committee shall be Final.



- 4. Members of 23 Towers will elect 2 Collegium members (TR-1 and TR-2) from their respective Towers. Please refer the annexure -1 attached.
- 5. Members of 15 Towers will elect one Collegium member (TR) from their respective Towers. Please refer the annexure -1 attached.
- 6. One member can file his/her nomination form for one post only.
- 7. Members can reject the member/s contesting the election by choosing "Rejection" option. Members can reject all the members contesting the election by choosing "none of them" option.
- 8. Proxy Vote is not allowed. Members shall cast their vote in person.
- 9. The contesting candidate can depute only one polling agent on the written and duly signed authorization slip submitted by the candidate himself/herself.
- 10. The programme of the election will be as under:

(V)	Conduct of elections from 9:00 AM to 1:30 PM at 2nd Floor, RWA Club Office, Omaxe Heights, Faridabad	28-11-2021
